#### Question #1

#### Question #3

If you could amend the constitution in any way, what would change and why?

#### Question #4

Some political pundits have argued that giving Supreme Court Justices a limited term would make battles of Supreme Court nominations less acrimonious and overall would be a benefit to the nation. Do you agree with this position?

### Question #5

Should members of certain religious sects be given exemption from military service or the draft for reasons of conscience?

### Question #6

What sorts of regulations on public political assemblies, such as protests, rallies, and strikes, are reasonable and constitutional?

### Question #7

What general principles should guide our thinking about when warrants are or are not required to conduct a search?

### Question #8

Should the government be allowed to restrict freedom of assembly during times of crisis or emergency? If so, what principles should govern these restrictions?

### Question #1

Many law enforcement agencies across the country currently use the practice of civil asset forfeiture. Is this practice a violation of the fifth amendment right to due process?

#### Question #2

Many have argued that the decision reached by the Supreme Court in the famous Citizens United Case inappropriately granted free speech rights to corporations. Do you agree with this view? To what extent should corporations be given rights under the constitution?

#### Question #3

The fifth amendment guarantees that eminent domain can only be exercised if citizens are given just compensation. Do you believe that this right is generally well protected in America? Are there any reforms which you believe would be helpful?

### Question #4

Should facial recognition technology use by law enforcement be regulated? What constitutional principles should guide this?

#### Question #5

Does the Fifth Amendment's protection against self-incrimination extend to physical evidence, such as blood or DNA samples?

#### Question #6

Is qualified immunity necessary to protect police officers from frivolous lawsuits or does it hinder police accountability?

## Question #7

Should the double jeopardy clause of the fifth amendment prevent an individual tried in a state court from being tried in a federal court for the same crime?

#### Question #8

To what degree do you believe the protections afforded by the Bill of Rights ought to be applied to undocumented immigrants living in the United States?

### Question #1

The United States Congress has not declared war since World War Two. Is there any harm in the United States waging wars without a technical declaration by congress?

#### Question #2

Should the Constitution be amended to promote a multi-party system? How?

#### Question #3

Is the Electoral College good for American Democracy? Would you advocate changing it, or leaving it as is?

#### Question #4

The 10th amendment was written to establish a division and balance of powers between the federal and state governments? Do you feel that our current system has maintained that balance appropriately? Are there any policy changes you would pursue in this regard?

#### Question #5

How do you think the U.S. can best balance the important concerns of religious freedom in the first amendment to the constitution with desires to protect people from identity based discrimination (for example, discrimination on the basis of sexual orientation)?

### Question #6

Should law enforcement officers seek and obtain a warrant before looking in the windows of a vehicle parked along a public road?

### Question #7

Do you believe it would violate the fourth amendment if the U.S. government conducted a warrantless wiretap of a phone outside of the borders of the United States and belonging to a citizen of a foreign nation if that wiretap were to record a conversation between the owner of the phone and a U.S. citizen?

#### Question #8

If religious practice comes into conflict with local, state, or federal law (for example in cases of religious drug use, practice of religious rites in prisons, etc.) what principles should guide when such religious practices are or are not protected by the first amendment?

Should the death penalty be considered "cruel and unusual punishment"?

#### Question #2

A commonly proposed amendment to the constitution would require the congress to balance the budget on an annual basis with a limited number of exceptions. Do you believe this amendment would be good for America?

### Question #3

A number of states have recently passed resolutions calling for an Article Five convention of the states to pass amendments to the constitution. Some have argued that an Article Five convention of the states is too dangerous because it could be used to radically change the constitution. Do you think that an Article Five convention of the states is a good way to make changes to the constitution?

#### Question #4

The U.S. constitution lays out a system of checks and balances. Some have argued that both the judicial and executive branches have upset that balance by taking on legislative powers that belong to the legislative branch. Do you agree or disagree?
